Agenda items

1. **Patching DISPA and DISPB** - opinion of CCom leadership staff - advise the agency where the incident is coming if they would like the channels patch, if so patch them. Example if county is chasing into the city, ask Lt if they would like to be patch to county for the duration of the chase. Sgt Benton suggested that we use Regional Pursuit for chases and have all agencies switch to that. It was decided that it will be up to the OIC to choose between DISP or Regional Pursuit.
2. **Send changes for UCSO through DRC** - Jay Gurian requested that any large changes to numbering of units, etc. be sent to DRC for approval. This way the changes can be disseminated to CCom staff and changed in policy/training materials prior to the effected day. It was requested that Susan be added to the mailing list for the roster changes.
3. **Forced Entry** - Sgt Benton stated that the UCSO can't give Fire/EMS permission to force entry into a home. They will respond when requested but they can only take a damage report, not give permission.
4. **Preventive Patrols & Radar Patrol** - Sgt Benton requested that units on these natures be marked on scene available at all times and given calls for service in their area. It was suggested that we have Gary check to see if we can alter the natures to recommend them if they are on these calls. Officers on Business Checks and Residential Checks are not to be made available unless they specifically indicate this, either over the radio or in the notes.
5. **Law Enforcement requesting EMS only** - County fire requested that for serious calls that Law request first responders as well as EMS. Law stated that sometimes the complaint maybe a serious type situation but they do not need first responders to respond, only EMS. Larry Brinker suggested that quick reference cards be made for Officers so that they can determine if Fire is needed as well as EMS.
6. **Update on VoiceAlert Automated Dispatch (Elsa)** - Larry Brinker gave an update on the progress of Elsa. They have worked out most of the bugs with the system. They are having some issues with tones and the selection of fire or medical tones for some stations. Testing is scheduled in the next few days. Her volume has been corrected and will be louder once she goes live.
7. **County Move-ups** - Gary advised that it is possible to add a special response layer for the nature code MOVEUP. This will allow each station to build out their response plans for which stations they want in this situation. This will allow for a uniform response plan from each dispatcher and/or Incident Commander.
