## NOTICE OF MUNICIPAL ELECTION UNION COUNTY, NORTH CAROLINA

A Municipal Election will be held on Tuesday, November 5, 2019 in Union County to vote in the following contests:

- Town of Fairview – Mayor, (2) Council seats
- Town of Hemby Bridge – (3) Alderman seats
- Town of Indian Trail – Mayor, (3) Council seats
- Village of Lake Park – Mayor, (3) Council seats, (1) Council (Unexpired Term) seat
- Town of Marshville – Mayor, (3) Council seats
- Village of Marvin – Mayor, (2) Council seats, (1) Referendum
- Town of Mineral Springs – Mayor, (3) Council seats
- City of Monroe – Mayor, (3) Council seats
- Town of Stallings – (1) Council-District 4 seat, (1) Council-District 5 seat
- Town of Unionville – (3) Commissioner seats
- Town of Waxhaw – Mayor, (2) Commissioner seats
- Town of Weddington – Mayor, (1) Council-District 2 seat, (1) Council-District 4 seat
- Village of Wesley Chapel – Mayor, (2) Council seats
- Town of Wingate – Mayor, (3) Commissioner seats

Polls will be open from 6:30 a.m. to 7:30 p.m. on the day of the election, Tuesday, November 5, 2019.

One-stop early voting will be held at the Union County Public Library (Griffin Room), 316 East Windsor St., Monroe, NC 28112 from Wednesday, October 16 until Friday, November 1. The Union County Public Library (Griffin Room) will be open weekdays 8:00 a.m. until 6:00 p.m. and on Saturdays from 9:00 a.m. until 1:00 p.m. Closed on Sundays. Canvass will be held at the Union County Board of Elections office at 11:00 a.m. on Friday, November 15.

Absentee voting by mail is available. Requests for an absentee ballot must be made on an absentee request form (available on the State Board of Elections website and at the county board of elections office), and must be received in the Union County Board of Elections office by 5:00 p.m. on Tuesday, October 29. Absentee voting requires the voter to complete an application on the return envelope that must be witnessed by two qualified persons or a notary public. Completed absentee ballots must be returned to the Union County Board of Elections by 5:00 p.m. on Election Day (ballots received by mail after this time will be timely if received within three

business days and postmarked by Election Day). Voters may receive assistance voting a mail-in absentee ballot from a qualified person of their choice. If the voter lives in a facility such as a nursing home, and the voter's near relative or legal guardian is not available, the voter or the facility can arrange to have the county board of elections schedule a visit by a Multipartisan Assistance Team to provide assistance and witnesses.

Voters voting in person are entitled to assistance by an election official, or, if assistance is needed due to disability or illiteracy, by a qualified person of their choice. Voting sites are accessible to all voters. Curbside voting is available for voters who are not able to enter voting sites.

All persons within a municipality who are registered to vote with the Union County Board of Elections may vote in this election. Persons who are not already registered to vote in the county must register by Friday, October 11 to be eligible to vote in this election. Voters who are not registered in the county by that deadline may register and vote during one stop early voting only, and will be required to provide documentation of their residence. Voters who wish to change party affiliation or who have changed name or address must do so by the registration deadline. Voters who fail to timely make a change in name or address in the county must update the information when presenting to vote, and may be required to vote a provisional ballot.
